Why It Works:

The original bullet is dense and overly technical. The optimized version:

- clarifies the *problem* you inherited
- highlights your role as the driver of the solution

Why It Works:

The original focuses on the features and team, but not *why it mattered*. The optimized form:

- centers your leadership
- highlights the friction you were solving
- ties everything back to the business-critical outcome: engagement growth

This shows product leadership, not feature supervision.

“redacted” (Bullet #4)

Original: “Managed API integrations with 8 brokerage firms and 6 market data providers, ensuring real-time portfolio and market data across equities, ETFs, mutual funds, cryptocurrencies, and options.”

Optimized (APR): Managed integrations across 14 brokerage and market data partners (Action) to eliminate inconsistent data freshness and fragmented portfolio sync issues (Problem), delivering reliable real-time data across equities, ETFs, mutual funds, crypto, and options (Result).

Why It Works:

Your original bullet is accurate, but it reads like operations. This version:

- frames the integrations as a *product problem*, not a checklist
- shows you understand system reliability and data quality — huge for trading platforms
- makes the complexity of the work explicit

This positions you squarely for platform PM roles (Robinhood, Coinbase, Stripe, etc.).

These four bullets now:
